

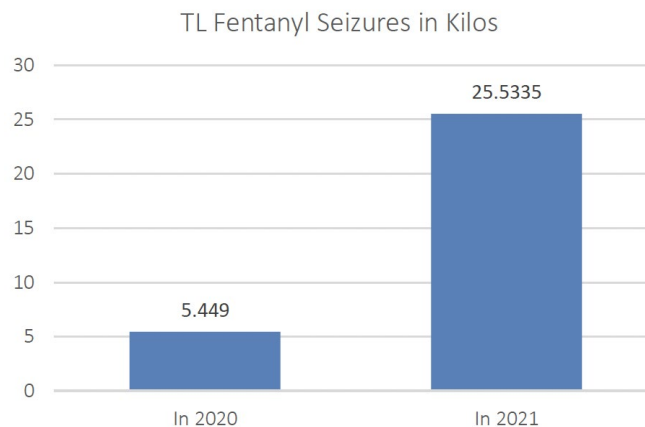

Tenderloin Total Narcotics and Cash Seized for 2021

First, the final year-end report from the SFPD Tenderloin Police District's "Total Narcotics and Cash Seized" spreadsheet contains a lot of detailed data, though its most frequently cited statistic shows...

- Tenderloin police officers seized more than 25.5 kilos of fentanyl in that single neighborhood over the course of 2021;
- Which is a nearly five-fold increase from the less-than 5.5 kilo fentanyl haul for calendar year 2020.
