Raynell this back and forth is a waste of time.

I'll reiterate again "right now the lack of face to face time with the supervisor is becoming a major hindrance to our work and advocacy. There are several pressing issues that we need to have his ear on."

We're also not feeling the respect and feel that we've been demoted since we are being pressed to meet with you (we/I have always worked directly with the supervisor and his/her chief of staff) --- the group views your former position at the SFMTA as a conflict of interest while we continue to try to navigate through the current SFMTA issues that our neighborhood is burdened with.

Again, we had 10 minutes with Bilal and 40 minutes with you on 2/27 and we haven't so much as even received a followup from you on the array of topics we discussed with you. This underscores our necessity to meet with Bilal so we can hear and understand his positions and focuses.

The team feels indifferent to how far up ahead the meeting date with Bilal is...it's simply nonnegotiable that we meet with him. Please provide available Thursday or Friday meeting times with Bilal.

In the meanwhile please note: while our members and readership know that the supervisor has seemingly de-prioritized us we have assured them that we collectively are not giving up hope to get our partnership with your office on track.
